

De Europa. European and Global Studies Journal Author's Guidelines

Hereafter author's guidelines for your issue:

- send contributors details: first and last name, Institution, email address (better if your institution's address)
- your article have to be sent in .doc/docx format (pc and mac) and in .pdf
- text formatting: 13 pt
- send 5-6 keywords, sent in a different file, in English and in the article language
- notes should be placed at the end of the page, should be numbered consecutively, and should not solely comprise references. Format 10 pt
- please organize the text so that all the part are clearly indicated: Headings must be indicated as
 1. and
subheadings as 1.1
and so on 1.1.1. etc
 2. and
2.1
and son on 2.1.1. etc
and so on
- Please do not separate paragraphs using a line or spacing tabulation.
- bold type is used **only** for headings
- For quotation up to 25 words: add the quotation between quotation marks: "quoted text", use italics for the quotation in a different language from the paper language ("*quoted tetx in foreing language*")
- For quotation with more than 25 words: do not use quotation marks but insert a new paragraph; format: 12 pt.
- Use italics for foreing words and not to emphasize
- Figures, tables and graphs should have short, descriptive titles, and their position in the text be clearly indicated.
- Please note that for tables and graphs you have to send them in their native file (.xls) and apart from the files

- Images: they must be sent apart from the text in 300 dpi (or more) resolution and with correct caption and/or source
- Annexes: if you include annexes to the text please note they must follow the same guidelines of your text.
- If you insert a Q&A in your text please organize this part of your thesis so that is clear the Q and the A:
Q: insert your text?
A: answer to your text
- References: please insert sources directly in the text as following: (Wodak 2015: 23)
- References have a titled section at the end of the article; authors are listed in alphabetical order and in the following below. For books:

Wodak Ruth (2015). *The Politics of Fear: What Right-Wing Populist Discourses Mean*. New York: SAGE.

For articles:

Luccetti Nicholas (2013). "Eritrea 1947-1950. La comunità italiana e il destino della regione". *Contemporanea*, XVI/2, 239-260.

For chapters:

Morelli Umberto (2015). "Il Parlamento europeo nella storia del processo di integrazione dell'Europa comunitaria". In: Marinella Belluati, Paolo Caraffini (eds). *L'Unione Europea tra istituzioni e opinione pubblica*. Rome: Carocci, 33-55.

- If available insert url for articles, chapters book at the end of each reference with access date (for Reference and footnotes)
- If available insert DOI or permalink, without access date (for Reference and footnotes)

Please note that post on Twitter have to be insert in text, footnote and references in the following way:

Text: (Author surname, 2021)

Footnote and references: Author name, Initials [@username]. (Year, Month Day). Text of tweet [Tweet]. Twitter. URL

- You can also insert a Sitography after References section in alphabetical order as follow:
